03/21/5.0 Chairman's Announcements & County Council's update

The Chairman had no announcements. Cllr P Hewitt updated the Council of the issues at the Tip Island after receiving many emails of complaint. Biffa Waste had seen an increase of 43% in visitors at their waste centres across the Staffordshire area. Traffic measurements had been put in place to assist with the problem. Questions were asked regarding the number of commercial vehicles visiting the recycling centre and vehicles out of the Cannock Chase area. Cllr B Jones expressed traffic concern when the Designer Village opened. Traffic management would be discussed at the next Cannock Chase Council community safety strategic board meeting.

Cllr Jones had further concern over the security situation once the Designer Village opened and did Staffordshire police have a plan in place to assist with extra arrests that may occur? Both County Councillors would report back to the Parish Council when further information had been obtained on the traffic and security issues.

03/21/6.0 Clerks Report

The Council noted the Clerks Report.

- The new Website was live: www.hhandw.org.uk
- Notice of Casual Vacancy had been displayed on the Website, Library Notice Board and Community Centre from 10th February to 1st March. No election had been called. The Notice to Co-opt had been displayed on the Council Website, Library Notice Board and Community Centre from Wednesday 3rd to 31st March 2021.
- Mill Green and Hawks Green Valley Nature Reserve leading to the designer village, it had been reported that
 many lights were not working. Concept Project Management confirmed that the lighting across the dam wall
 was currently undergoing testing, any lights not working should be picked up and rectified.
- Facebook members currently 1616.
- Ongoing issues with Water Plus regarding an outstanding bill from when the Council owned the Cabin. The
 Cabin was demolished in June 2018. The Clerk had requested a site plan from Cannock Chase Council and a
 letter confirming the termination of the lease in 2018, this had been forwarded to Water Plus as requested.
- The Cabin Charity account registered with the Charity Commissioner had been closed.
- The Clerk had a meeting with the Clerk at Norton Canes Parish Council to discuss the option of a shared Traffic Warden for both Parishes, it was agreed to investigate the possibility in the future and required budgets.
- 10 Students from Kingsmead would be spending half a day at Cannel Mount on Monday, 8th March, part of the Schools wellbeing days.
- Attendance Register of Council and committee Meetings over the past 14 months were recorded.
- A reminder of current Committee's agreed for 2020-21, a schedule of meetings dates of the Parish Council
 and committee for the forthcoming year and a list of Councillor's Training Course attended during 2020-21.

03/21/7.0 Police Report

- Youths throwing eggs: there had been a few incidents where youths had thrown eggs at houses in streets off Lyndhurst Road, Salisbury Drive, Cramwell Road and Chaplin Street. CCTV images were available, unfortunately they were not clear enough to ID any of the youths causing the problem. It was presumed that this was the same group of youths that had been causing problems on Kent Place, where they were continually playing knock door run on residents' properties. Hi-Vis patrols at these locations would continue especially past 1900hrs. Councillor to talk with local shops and make them aware of selling eggs to children.
- Gorsemoor Park: due to the recent anti-social behaviour from youths, it was expected that the issues at the park would start picking back up. In order to prevent and deter the issues the PCSO's aim was to show as much presence as possible around the area.
- Off road bikes: the calls received had reduced, the PCSO's would continue to pay passing attention to the location in hopes of catching the people responsible or developing more intel on the individuals causing the issues.
- Drug related issues around Tesco's- this was an ongoing issue that was been tackled slowly starting to tackle.
 A large amount of CCR's had been conducted the intel logs had been recorded in the hope of getting larger picture of the problem and work on this. Unfortunately, a lot of the older intel had now been outdated, so it would be a case of redoing a large amount in the hope of getting a better outcome.

Gorsemoor School: the parking at school time had become very haphazard and at one point before lockdown parents were parking on the corner pavement.

Badgers Way: top entrance nearest Five ways school, parents parked on the slip road and blocked the view from traffic pulling out into Hayes Way, no yellow lines were present. It was suggested to ask the new Crime Commissioner to a Council meeting.
