The Chairman advised Council that the defibrillator training that had been arranged had been cancelled, Council would be advised of a new date as soon as one had been arranged. Councillors had been reminded of the litter pick on Saturday morning.

The Chairman informed Council that no election had been called, the notice of co-option had been put on the Council website and notice boards, application forms would be accepted from the 6th July to the 31st August 2022.

The Chairman advised Council of the problems occurring at Heath Hayes park, car park and a complaint that had been received, District and County Councillors would arrange a meeting with the resident as matters raised were not Parish issues.

County Councillor Thompson advised Council that the street wardens had patrolled the area on 8 occasions during May and June and issued penalty notices at Chapel Street, Stafford Street, Gorsemoor Road and Cleeton Street. No penalties notices were issued on Gladstone Road, the shops close to Gladstone Road would be approached to ask their customers to park considerately. 4 school patrols had taken place.

County Councillor Hewitt advised Council that there had been a very significant increase in C19 numbers across the country mostly due to sub variant 5 of Omicron, which was highly contagious. Symptoms that were common were sneezing runny nose sore throat fatigue etc. The risk of hospitalisation for any individual was thought to be half that of previous variants but the number of people getting it were high, hospital admissions were increasing. All over 50 should be offered an autumn booster. Some authorities consider flu to be more of a threat this winter than C19. The advice was to continue to be vaccinated.

The County Councillor had no further information on the sale of Horseshoe Drive.
